Secretarial support for the Committee will be provided by the P.A.I.C.

The terms and conditions of the Committee shall be: -

- (a) To consider and determine special packages of incentives as well as the steps required by way of relaxation of Rules & Regulations and provision of Legal, Institutional and Financial dispensation to facilitate establishment of new as well as for existing Agro-Industrial units undertaking expansion.
- (b) To monitor the progress of the various clearances required by the projects which it deals with, including those required from the Punjab Pollution Control Board.
- (c) The limit of Fixed Capital Investment by a unit for eligibility of a Special Package shall be Rs.100 crore and above. This limit will be Rs.25 crore for Border Districts.
- (d) No formal examination of proposals put up to the Committee will be necessary either in the Administrative Department concerned or in Finance Department and decisions of the Committee would be conveyed to the concerned departments. All decisions taken by the Committee shall be considered Directives of the Government.
