1. The expression of Interest (EOI) should reach this office on or before 14.11.2019 by 2 pm and these shall be opened on the same day at 2.30 pm.
2. Offer will be accepted in sealed envelope.
3. The rate quoted for the transportation of kinnow shall be valid upto 31st March, 2020.
4. Each of the document/paper submitted by the party should be duly signed by the party.
5. No advance would be given to the driver at dispatch point by PAGREXCO. The payment would be made to the driver/transporter only once the truck was unloaded at destination market.
6. If there is any shortage of boxes at destination market or any damage in boxes, the payment would be deducted from the driver payment as per sale price of box.
7. It shall be full responsibility of driver/transporter, that during loading of boxes in truck, he should count each and every box, so that there would be no mismatch in no of boxes at destination market.
8. Driver has to submit photocopy of all the documents related to vehicle at dispatch point to PAGREXCO official and also keep to all original with the truck and need to show wherever asked by PAGREXCO official.
9. Transporter would be informed early in the morning every day about that particular day requirement of truck and he has to arrange/send the truck as per requirement maximum by 5 pm every day.
10. Transporter has to provide transportation bilti (Slip) every time along with truck.
11. If there is delay in reaching destination market as per schedule time by negligence of driver, penalty would be imposed on driver/transporter as per PAGREXCO sole discretion.
12. The successful bidder shall abide by all laws, rules, regulations and PAGREXCO shall not be responsible for any violation.
