1. All applications must accompany Application Form/KYC Form along with all documents.
2. Mere submission of application shall not entitle the applicant for subsidy, as it will be granted on merits.
3. Subsidy to be provided to farmers & exporters of Punjab who would market their produce to distant markets of India & export markets. For Domestic market, only railway freight subsidy will be provided.
4. Following documents to be submitted along with application for claiming the freight Subsidy:

**For Domestic Marketing:**

- (i) Railway rack booking slip.

**For Export Marketing:**

- (i) Bill of Lading (BL)
- (ii) Invoice
- (iii) Packing list
- (iv) Phytosanitary Certificate
- (v) Shipping Bill
- (vi) Certificate of Origin
- (vii) Bank Statement reflecting Sale realization

5. Subsidy to be claimed within 6 months from the sale of Potato.
