1. The rates quoted above are exclusive of taxes/levies, which shall be paid extra as applicable
2. I/We shall arrange my/our own transport and labour for taking away the stocks.
3. The rates quoted in annexure “B” are valid for a period of 45 days from the date of opening of tenders extendable for another 15 days.
4. Acceptance of this offer by PAFC Ltd or by any officer authorized by PAFC Ltd shall constitute valid/legal contract between me/us and PAFC Ltd.
5. The earnest money has been deposited on _____ through RTGS and the UTR number is _____
6. I/we hereby agree that the EMD deposited by me may be converted into security deposit on being a successful bidder. I/we further agree that in case we fail to lift the material within the stipulated period as would be given in the sale order or could not fulfill the terms and conditions of this contract, our security as whole or part thereof may be forfeited by PAFC Ltd. for which I/we shall have no objection, whatsoever, in addition to the right of PAFC Ltd. to make risk sale of goods.
7. I/we also agree to pay liquidated damages to PAFC Ltd. on account of non-fulfillment of the terms and conditions of the contract.
8. I/we understand that the weight per unserviceable stock articles should be approximately as under:
 - i) LDPE polythene covers: 45.00 kg per cover
 - ii) Poly sheets: 20.00 kg per sheet
 - iii) Multilayered cross laminated covers 20.00 kg per cover
 - iii) Meshnets: 3.400 Kg per net

The weight can however increase or decrease and we shall have no claim what so ever.
