## Background:-

Punjab Agri Export Corporation Limited (PAGREXCO), a Punjab State Government Undertaking, is engaged in promotion, processing, marketing and export facilitation of agricultural and food products from the State of Punjab. PAGREXCO has established processing and marketing systems for a range of fruit and vegetable-based products including juices, jams, spreads, marmalades, pulp, paste and other value-added agri products. In alignment with the objectives of the PM Formalisation of Micro Food Processing Enterprises Scheme (PMFME), PAGREXCO aims to strengthen the ecosystem of Micro Processing Units (MPUs) in the State by facilitating capacity building, standardization and regulatory compliance. The PMFME Scheme emphasizes formalization, skill upgradation, quality enhancement and improved competitiveness of micro food processing enterprises.

Recognizing the need to enhance production efficiency, improve packaging standards, ensure food safety compliance and promote adoption of best manufacturing practices, PAGREXCO proposes to undertake a State-Level Capacity Building Programme for MPUs engaged in processing of fruit, vegetable and other value-added agri products.

Through this initiative, PAGREXCO intends to support micro food processing units in upgrading their operational systems, improving product quality and aligning with statutory and market requirements, thereby contributing to the overall growth of the food processing sector in Punjab.

**Requirement:-**

PAGREXCO proposes to undertake a State-Level Capacity Building Programme for Micro Processing Units (MPUs) across Punjab engaged in processing of Juices, Jams, Spreads, Sauces, Marmalades, Honey, Tomato soup, Tomato Puree Popcorn, Pickle, Dry fruits and other Fruit & Vegetable-Based and Value-Added Agri Products under the PMFME Scheme.

- **Scope of Work:-**

- 1. Product Range:**

The participating Micro Processing Units (MPUs) should be engaged in processing of Juices, Jams, Sauces, Marmalades, Honey, Tomato soup, Tomato Puree, popcorn, dry fruits, pickles and Ketchup or other Fruit & Vegetable-Based and Value-Added Agri Products. The unit shall clearly indicate the product categories and SKUs currently being manufactured along with basic production details such as daily capacity etc.

- 2. Quality Standards:**

The participating MPU must ensure that its products comply with applicable Food Safety Standards and regulations prescribed by the Food Safety and Standards Authority of India (FSSAI). The unit should possess a valid FSSAI License and demonstrate willingness to upgrade quality and regulatory compliance as part of the training programme.

- 3. Packaging:**

The participating MPU shall provide details of packaging materials currently being used, including primary and secondary packaging formats, labelling compliance and shelf-life declaration practices. During the training programme, guidance shall be provided on improving packaging standards, labelling compliance and branding alignment as per regulatory requirements.
